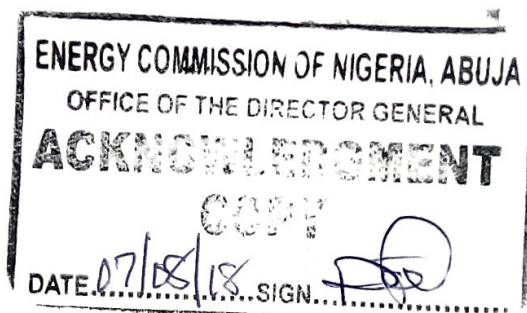

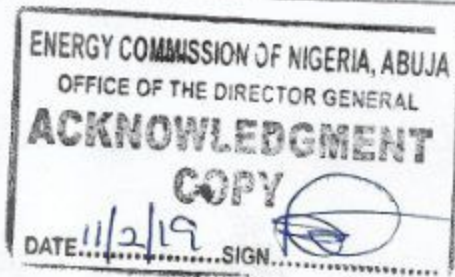

## RE: REQUEST FOR INFORMATION ON THE 2017 ZONAL INTERVENTION PROJECTS EXECUTION STATUS

Refer to our letter dated 1<sup>st</sup> August, 2018 on the above subject matter referenced ENetSuD/FOI/ZIP/01/8 and received by your office on the 7<sup>th</sup> August, 2018, in which we requested for information on the Construction of 3 km road in Asa/Ilorin west Federal Constituency, Kwara state as part of 2017 Zonal Intervention Project (ZIP) nominated by our Federal constituency representative.

In your response dated 28<sup>th</sup> August, 2018, you informed us that the project was moved to the Nigerian Building and Road Research Institute (NBRRI) through a corrigendum, and added that you transferred the funds released for the project to NBRRI for its execution.
