## REQUEST FOR INFORMATION ON THE 2017 ZONAL INTERVENTION PROJECTS EXECUTION STATUS

The above named registered and Kwara-based Civil Society Organization was established with the primary aim of promoting good governance and ensuring Transparency and Accountability.

We are aware that your Institute was captured in the 2016 and 2017 Capital budget for the execution of the following Zonal Intervention Projects (ZIP) nominated by our Federal constituency representatives:

- 1. Construction of 4 km Road in Asa and Ilorin West, Kwara State (2016 ZIP)
- 2. Construction of 1 km Station Road, Offa LGA, Kwara State (2016 ZIP)
- 3. Construction of 1.5 km Igosun Road in Offa LGA, Kwara State (2016 ZIP)
- 4. Construction of 1.5 km Igosun road in Offa LGA, Kwara state (2017 ZIP)
- 5. Construction of 1.5 km Muu road in Offa LGA, Kwara state (2017 ZIP)

We are also aware that the Construction of 3 km road in Asa/Ilorin West Federal Constituency, appropriated in the 2017 Capital budget and domiciled in the Energy Commission of Nigeria (ECN) was later moved to your Institute through a Corrigendum, and the funds released to ECN was transferred to your Institute for the execution of the project.

Furthermore, your Institute executed the Construction of Crown Road in Horin South, Kwara State in 2017.

We are requesting you to explicitly provide us with the following information on ALL the seven (7) projects listed above:

- 1. The amount appropriated for each project in the approved Capital budget
- 2. The actual amount released for each project to your Institute for execution
- 3. The technical details of the scope of the total money received by your Institute for each project
- The details of all your lawful deductions from the money received by your Institute for each project
- 5. The exact amount you released to each contractor for each project
- 6. The technical details of each stage of funds that you released to each contractor
- 7. The Bill of Engineering Measurement and Evaluation (BEME) of each project
- 8. The detailed information of the contractor that you awarded each project to
- 9. The current status of each project

Moreover, our thorough check of the 2016 and 2017 Capital budget shows that the **Crown Road** you constructed **was not appropriated in either of the year**. In addition to all the above information requested for, you are further requested to explain the source of fund for this Crown Road in Ilorin South. A copy of any official document that shows the Appropriation for this Crown Road is required.

Kindly respond to our request within 7 days of receipt of this letter as stipulated in the Freedom of Information (FOI) Act 2011 via our email (info@enetsud.org), failure of which we shall not hesitate to take all the necessary legal actions.

We wish to inform you that your failure to respond has left us with no option than to write you this preaction notice.


